

Institute for Intellectual Property of Bosnia and Herzegovina (hereinafter referred to as the Institute), pursuant to Article 11 Law on collective management of copyright and related rights (Official Gazette, No. 63/10; hereinafter: the Law), Article 18 of the Bylaw on the manner and form of fulfillment of conditions for granting licenses to legal entities for the collective management of copyright and related rights (Official Gazette No. 44/11, 49/16, hereinafter referred to as the Bylaw) And the article 193, paragraph (1) of the Administrative Procedure (Official Gazette, no. 29/02, 12/04, 88/07, 93/09 and 41/13), solving the application the applicant "ORIGINAL" Association for the realization and protection of reproduction rights, Pijačna no. 94, Ilidža, Sarajevo, for the issuance of a license for collective management of rights to private and other internal use, after conducting the procedure for examining the conditions for granting the license, issues

Decision

to grant a license for the collective management of rights to private and other internal use

1. The application of the Association for the Realization and Protection of Reproduction Rights "ORIGINAL", Pijačna 94, Ilidža Sarajevo, is ADOPTED and the license for the collective management of rights of authors of written works published in paper form and related rights of the publishers of printed editions, for private and other internal use, is issued
2. The license referred to in item 1 of this decision shall be issued for the collective realization of the following copyrights of the authors of works issued in printed form and related rights of the publishers of printed issues:
 - the right to a fee collected through the first sale or import of new photocopiers
 - the right to compensation from created photocopies intended for sale, paid by natural or legal persons who perform photocopying services;
3. This Decision shall enter into force on the day of its adoption.
4. This Decision will be published in the "Official Gazette of BiH" and in the "Official Gazette of the Institute"

Explanation

Process

An application for a license for the collective management of rights to private and other internal use Association for the realization and protection of reproduction rights "ORIGINAL", Pijačna no. 94, Ilidža, Sarajevo (hereinafter ORIGINAL) has submitted, to the Institute for Intellectual Property of Bosnia and Herzegovina, a application for issuance of a license to perform the activities for the collective management of copyright and related rights of the authors of written works published in printed form and related rights of the publishers of printed editions for private and other internal use. The application was received on 15/3/2017 under the number 03-47-5-793 / 17. The following documents were submitted along with the application: Decision on registration of the ORIGINAL association into the Register of Associations of the Ministry of Justice of BiH, number UP09-07-1-734 / 16 from 1/9/2016; Statute of the ORIGINAL association number 02/16, adopted by the Assembly of the Association from 28/3/2016; decision on correction of the Article 36 of the Statute No. 11/16 from 16/11/2016; decision on the

appointment of the President of the association number 04/16 from 28/03/2016, which is authorized to represent the association; contract for lease of office of 20m², concluded with the landlord Ljiljana Mitić-Rorić, from 25/1/2016; list of office equipment of the association from 14/3/2017; contract of indefinite duration with Lejla Gačanica, day 14/12/2016; certified application form for Lejla Gačanica with the Tax Administration of the FBiH (form JS3100); certified copy of the diploma of the Law Faculty in Sarajevo for Lejla Gačanica; CV for the stated; a certificate of knowledge of English language for Lejla Gačanica of Gymnasium "Bihać" The Bosnian Student Project- Achievement in the student's class of the English Language program, American English conversation cours; contract on volunteering concluded with Naida Vidović, concluded on 20/12/2016; contract for performing accounting and bookkeeping activities concluded with "Business line" d.o.o. Sarajevo from 25/10/2016; print of the active website ww.original.co.ba; business plan from February 2017 and strategic plan; decision on adoption of strategic plan No. 08/16 from 16/11/2016, contract on opening an account in Unicredit Bank from 11/9/2016 and confirmation of Unicredit Bank about funds on the account of the association; loan agreements concluded with Ivica Rorić, Nova Dječija knjiga Sarajevo and Buybook d.o.o. Sarajevo; contract on provision of telecommunication services concluded on 7/12/2016 with BH Telecom Sarajevo, with annex of the contract; the application form for membership in the Association for authors Mehmed Đedović, Haris Alić, Budislav Vojinović, Goran Simić, Ivica Pandžić and Goran Samardžić; and for the following publishers: Media Center, Agarthi comics, Bosanska riječ, Buybook, Centar za informativnu dekontaminaciju mladih, Dječija knjiga, Dobra knjiga, Nova dječija knjiga, Planjax kommerc, Association Međunarodni festival književnosti, Association of textbooks and teaching aids, Association of literary creators, publishers and booksellers in BiH and "ART SCENA"; decision of the Assembly of Association on admission to regular membership for mentioned right holders; Bylaw on honorary membership in the association "ORIGINAL" number 10/16 o 16/11/2016; and letters of support of similar collective organizations from abroad (IFRRO Belgium, Public Union from Azerbaijan, Dilia from Prague, Kopitol from Poland, Lita from Slovakia, RSZ from Hungary, Repro Bel from Belgium, Sazor giz from Slovenia, Zana from Croatia and YAYBIR from Turkey).

The Institute has reviewed the documentation submitted with the application of the association "ORIGINAL", and in the process of examining conditions for issuing a license for the collective management of rights of authors of written works published in paper form and related rights of the publisher of printed editions, for private and other internal use, found that application is not entirely complete and by the call, number 03-47-5-193-2 / 17VT from 5/5/2017, invited the applicant to edit it and submit the following to the Institute within 60 days from the date of receipt of the invitation:

1. Clearly indicate the right holders and the right for which the license for the collective management of rights is sought, in accordance with the Law on the Collective Management of Copyright and Related Rights,
2. Submit the Decision on the Establishment of the Association "Original" with the goals and activities of the Association, in accordance with the Law on the Collective Management of Copyright and Related Rights,

3. Submit the Statute of the Association verified by the Ministry of Justice of BiH and regulate it in accordance with the Law on Collective Management of Copyright and Related Rights, as follows:

- precisely define the activity that the Association intends to deal with in accordance with the Law on the Collective Management of Copyright and Related Rights,
- align membership of the Association with Articles 15 and 16 of the said Law (members of the collective organization are the right holders who have entrusted the collective organization with the exercise of their rights, that is, authors of works published in printed form and publishers of printed editions)
- basic principles and rules for the distribution of collected fees, which must ensure the proportionality, appropriateness and fairness of the allocation and must effectively prevent any arbitrariness, will be prescribed by the Statute in accordance with Article 21 paragraph (3) of the Law,
- in Article 20 of the Statute (competencies of the Assembly), add that the Assembly adopts the annual plan for the distribution of collected fees in accordance with the principles and rules for the distribution of the collected fees determined in advance by the Statute
- Establish the Association's Professional Service and determine its competencies by Statute (in accordance with Article 3 of the Law)
- Align the revenues of the Association with the activity that is intended to be performed (specify the provisions of the Statute relating to the use of funds derived from interest, dividends, capital gains, etc., delete membership fee as income, and specify that the income are fees for the use of copyright works of related rights that are collected from users)

4. Submit a list of works that will constitute repertoire of the collective organization, in accordance with Art. 10 paragraph (2) item c) of the Law and 4th Regulations

5. Submit an amended business plan, especially in the financial part, and align it with the type of rights and type of work for which the license for collective gain is sought;

During the deadline for editing the application, the applicant, before the expiration of the deadline for editing, on 3/7/2017 filed a request for extension of the deadline for editing the application. The conclusion of the Institute number: 03-47-5-193-4 / 17VT of 5/7/2017 allowed the extension of the deadline within 30 days from the day the deadline for the call for editing the application expired.

Acting upon the invitation of the Institute, the applicant submitted, within the extended deadline, a submission received at the Institute on 9/8/2017, under the number 03-47-5-193-5 / 17, the following documentation:

Decision on the establishment of ORIGINAL Association number 01/16 of 28/03/2016; amended business plan adopted at the session of the Association Assembly held on 22/6/2017; decision of the Assembly of the ORIGINAL Association on the adoption of amendments to the business plan number: 06/17 from 22/6/2017. New application forms for membership in the Association were submitted for the following

members (publishers and authors): Association of writers of the Republic of Srpska (130 members), Association of artists Planet Poezija, Imprimatur doo, Croatian lexicographic institute of BiH, Association of Publishers of RS, "Art rabic" doo, Synopsis doo, Milenko Mišo Marić, Mehmedalija Lilić, Milan Cvjetinović, Ranko Pavlović, Arifa Isaković, Nenad Novaković, Šefket Arslanagić, Tatjana Neidhardt, Predrag Bjelošević, Ivica Rorić, Naida Vidović, Damir Uzunović and Haris Alić, and the decision of the Assembly of the Association on admission to regular membership of aforementioned holders. A list of works from all individual rights holders was also submitted, consisted of 336 works registered by authors and 1831 the works registered by publishers, or a total of 2167 written works published in printed form, which form the repertoire of ORIGINAL.

Considering that the applicant failed to register the made changes in the Register of Associations and Foundations maintained by the Ministry of Justice of BiH within the deadline set and verify the amendments to the Statute of the Association, the applicant requested additional extension of the deadline for submitting the mentioned request for additional documentation on 9/8/2017. The conclusion of the Institute number 03-47-5-193-6 / 17VT from 17/8/2017 allowed extension of the deadline for 30 days.

In the extended deadline, on 6/9/2017, the applicant submitted to the Institute a Decision on amending the Decision on enrollment in the Register of Associations with the Ministry of Justice of BiH 8/8/2017 and the new Statute of the Association ORIGINAL No. 05/15 of 22/6/2017, certified at the Ministry of Justice of BiH on 8/8/2017.

During the course of the proceedings, on 26/10/2017, the applicant submitted a supplement to the application i.e. membership application forms for the association for 12 authors (Ljiljana Mitić Rorić, Nihad Hasanović, Selvedin Alić, Dragan Vuk Rodić, Sead Seković, Kristina Ljevak, Marija Feketa Sullivan, Goran Samardžić, Ivica Rorić, Naida Vidović, Damir Uzunović, Haris Alić) and addition to the repertoire with 255 works. The total repertoire of the ORIGINAL association consists of 426 works registered by authors and 1996 works registered by publishers, or a total of 2422 works published in printed form.

By examining the complete documentation submitted with the application to the Institute, it has been established that the Applicant has provided all relevant information and documentation in accordance with Article 10 paragraph (2) of the Law on the Collective Management of Copyright and Related Rights and Articles 4, 5, 6 and 7 of the Bylaw on the manner and form of fulfilling the conditions for granting a license to legal entities for performing collective work of copyright and related rights:

1) Decision on registration of associations for exercising and protection of reproduction rights ORIGINAL in the Register of Associations with the Ministry of Justice of BiH number UP09-07-1-734 / 16 of 1/9/2016 as amended on 8/8/2017, which is, within the meaning of Article 8 paragraph (1) of the Law on the Collective Realization of Copyright and Related Rights, proof that a legal entity has the status of an association that operates throughout the territory of Bosnia and Herzegovina.

2) The Statute of the Association for the Management and Protection of Reproductive Rights ORIGINAL No. 02/16 adopted at the Assembly of Associations held on 28/3/2016 with Amendments to the Association Statute No. 05/15 adopted at the Assembly held on 22/6/2017, verified by the Ministry of

Justice of BiH on 8/8/2017 which establishes the bodies and their responsibilities for the collective management of rights to private and other internal use

3) Data on persons who are authorized to represent a collective organization. Pursuant to Article 10, paragraph (2), item b) of the Law on the Collective Management of Copyright and Related Rights, the Applicant submitted the Decision of the Assembly of the Association ORIGINAL on the appointment of Association President No. 04/16 of 28/3/2016 who is authorized to represent association. The person authorized to represent the association is Goran Simić, president of the ORIGINAL association

4) Data on right holders, authors of written works issued in printed form and publishers of printed editions that are members of the association for the realization and protection of reproduction rights ORIGINAL. The applicant submitted evidence of membership in the association with 27 authors of written editions and evidence of membership in the association for professional associations of authors - the Association of Writers of Republika Srpska (which has 130 members), Association of Planet poetry from Sarajevo, and 19 publishers (Bosanska riječ, Buybook, Agarthi Comics, Dječija knjiga, Nova dječija knjiga, Planjax komerc, Association of Publishers of Textbooks and Teaching Resources, Association of Publishers of the Republic of Srpska, Synopsis, Croatian Lexicographic Institute Mostar, Imprimatur, Association of literary creators, publishers and booksellers in BiH, Publishing company and services Dobra knjiga d.o.o. etc. making a total of 46 holders (authors and publishers) to private and other internal use.

5) A list of works that will form repertoire of the collective organization. In accordance with Article 4 of the Bylaw, the Applicant provided the Institute with information on the works that will form the repertoire of the collective organization, while the publishers registered 1996 editions, which totals in 2442 works registered as a repertoire of the collective organization, which contains the following data: title, publisher, author, ISBN, year of publication and type of work.

6) Evidence on the fulfillment of technical assumptions for the efficient performance of collective management of copyright. In accordance with Article 5 of the Bylaw, the Applicant submitted the following evidence to the Institute: a lease agreement for a 20m² office space, concluded with the landlord Ljiljana Mitić-Rorić, on 25/1/2016; list of office equipment and means for communication of the association from 14/3/2017; contract on provision of telecommunication services concluded on 7/12/2016 with BH Telecom Sarajevo, with an annex to the contract, registered domain and web site www.original.co.ba, the e-mail address is info@original.co.ba, and the print of the active web site www.original.co.ba

7) Evidence on the fulfillment of personnel assumptions for the efficient performance of collective rights exercises. In accordance with Article 6 of the Bylaw, the Applicant submitted to the Institute relevant evidence on the fulfillment of conditions related to the professional service of the association, as follows: contract of indefinite duration with Lejla Gačanica, day 14/12/2016; certified application form for Lejla Gačanica with the Tax Administration of the FBiH (form JS3100); certified copy of the diploma of the Law Faculty in Sarajevo for Lajla Gačanica; CV for the stated; a certificate of knowledge of English language for Lejla Gačanica of Gymnasium "Bihać" The Bosnian Student Project- Achivement in the student's class of the English Language program, American English conversation cours

8) Business plan of the association "ORIGINAL", Pijačna br. 94, Ilidža, Sarajevo. In accordance with Article 7 of the Rules, the Applicant submitted to the Institute a Business Plan (for the period 2017-2019) which contains:

- information on the legal entity (legal status, persons authorized to represent and the history of copyright protection of the right to private and other internal use of authors of written works published in paper form and related rights of the publishers of printed editions on the territory of BiH)
- an analysis of the existing situation in the area of use and protection of the right to private and other internal use in BiH,
- information about the professional service, technical conditions for undisturbed performance of activities and personnel qualification
- a description of the intended way of performing the activity and the strategy for its implementation,
- economic and financial projection, which includes:
 - the funds intended for carrying out the activity
 - estimation of the expected amount of collected fees from users per year
 - an estimate of the amount of funds to be allocated
 - estimation of the costs of the operations of the collective organization.,

In the sense of Article 7, paragraph 6 of the Bylaw, the Applicant also submitted to the Institute and official bank data on funds on the account of a legal entity in the amount of BAM 61,869.28 (Unicredit bank's confirmation from 7/3/2017).

9) Decision of the Assembly on adoption of the business plan of the Association "Original". In accordance with Article 7 paragraph (2) of the Bylaw, the Applicant submitted to the Institute a decision on the adoption of the association's business plan No. 06/17 from 22/6/2017.

10) Declarations of readiness to conclude reciprocal contracts. Along with the application applicant has submitted the declaration of readiness of collective organizations from abroad for the conclusion of reciprocal agreements in the event that the association ORIGINAL obtains a license for the collective management of rights to private and other internal use authors of written works issued in paper form and related rights of the publisher of printed editions. Statements from similar organizations from abroad were sent out (IFRRO Belgium, Public Union from Azerbaijan, Dilia from Prague, Kopitol from Poland, Lita from Slovakia, RSZ from Hungary, Repro Bel from Belgium, Sazor giz from Slovenia, Zana from Croatia and YAYBIR from Turkey).

REASONS FOR GRANTING THE LICENSE

Acting upon the request of the applicant, the Institute has been guided by the provisions on the conditions for granting a license for the collective realization of copyright and related rights by the Law on the

Collective Management of Copyright and Related Rights (Official Gazette of BiH No. 63/10), the provisions of the Bylaw on the manner and form of fulfilling the conditions for granting the license to legal persons for performing collective work of copyright and related rights (Official Gazette of BiH No. 44/11 and 49/16) and the principles of the Law on Administrative Procedure (Official Gazette of BiH ", No. 29/02, 12/04, 88 / 07, 93/09 and 41/13).

In the procedure for examining the conditions for issuing the license, the Institute found that:

1) The Association for the Realization and Protection of Reproduction Rights ORIGINAL Ilidža Sarajevo was registered in the Register of Associations with the Ministry of Justice of BiH, number: UP09-07-1-734 / 16 of 1 / 9/2016, with amendments from 8/8/2017 for performing collective management of rights in accordance with Article 3 of the Bylaw, and as an association, in the sense of Article 8 of the Law on collective management of copyright and related rights and the Law on associations and Foundations of Bosnia and Herzegovina, operates on the territory of the whole of Bosnia and Herzegovina;

2) The Statute of the Association for the Realization and Protection of Reproduction Rights ORIGINAL is in compliance with the provisions of the Law on the Collective Management of Copyright and Related Rights and contains important elements related to: name and address of the Association, goals and activities of the Association in accordance with Article 3 of the Law, internationally accepted principles for the allocation of revenue collected from fees for the use of copyright and related rights including the principle of conscience and honesty, the principle of equity, the principle of objectivity, the principle of efficiency, the principle of cost-effectiveness and the principle of transparency, which are, as business standards, set forth in Article 7 of the Law; membership in the association is regulated in accordance with Article 16 of the Law; In accordance with the Law on Associations and Foundations of Bosnia and Herzegovina and the Law on the Collective Management of Copyright and Related Rights, the organs of the Association are supervised by members of the Association within the meaning of Article 19 of the Law on the Collective Management of Copyright and Related Rights. The Statute establishes basic principles and rules for the allocation of fees to authors of written works and publishers, in accordance with Article 22 paragraph (2) of the Law. It was established that the Article 19 of the Statute of the Association for the Realization and Protection of Reproduction Rights ORIGINAL provided that the Assembly has the competence to pass and adopt: the Statute, amendments to the Statute and other general acts of the Association, rules of procedure of the Assembly of Association, program of work of the association and its bodies, decides on the merger, division and termination of the association's activities, as well as other status changes of the association, the annual program and the work plan of the association, the financial plan of the association, the report on the execution of the financial plan of the association, reviews and adopts reports prepared by the Steering Committee and the Supervisory Board, appoints and dismisses the President of the Assembly and members of the Steering Committee and Supervisory Board, appoints persons authorized to represent associations in legal transactions, proposes a financial plan for the next year, which includes a cost business plan, adopts the annual allocation plan in accordance with the principles and rules of distribution established by the Statute, brings and adopts decisions on deductions from collected fees for cultural and social purposes up to a limit prescribed by law, gives opinion on the audit report and annual report on work and decides on all other issues which are not within the competence of other bodies. The competencies of the Steering Committee are defined by Article 24 of the Statute of the ORIGINAL

Association, which are: preparing sessions of the Assembly, preparing draft of the Statute, its amendments and other acts passed by the Assembly, implementing determined policies, conclusions and other decisions of the Assembly, managing the assets of the association, establishing and proposing a financial plan for the realization, use and disposition of the funds of the association, adopted by the Assembly, giving suggestions, opinions and initiatives for achieving the objectives of the Association, submitting an annual report on its work to the Assembly for approval, preparing analyzes, information and other materials for the Assembly, monitoring the implementation of the financial plan of the Association and makes decisions on the use of funds within its jurisdiction, performing other duties in accordance with the law, this Statute and those which the Assembly puts in its jurisdiction. The competencies of the Supervisory Board are determined by Article 29 of the Statute, which is: performing overall supervision of the work of the association and reporting it to the Assembly, controlling the financial and material operations of the association, reviewing the financial documents, making reports on the actual situation and informing the Steering Committee, The Assembly and the President of the Association, giving an opinion on the audit report, giving an opinion on the annual report of the management bodies on the amount of collected fees, their distribution, the costs of the association's operations, the execution of collective agreements and individual contracts with beneficiaries, and the execution of contracts concluded with foreign collective organizations.

3) The person authorized to represent the association is Goran Simić, president of the ORIGINAL association, registered in the Register of Associations with the Ministry of Justice of BiH.

4) Association for the realization and protection of reproduction rights "ORIGINAL" submitted evidence of membership in the association with 27 authors of written editions and evidence of membership in the association for professional associations of authors - the Association of Writers of Republika Srpska (which has 130 members), Association of Planet poetry from Sarajevo, and 19 publishers (Bosanska riječ, Buybook, Agarthi Comics, Dječija knjiga, Nova dječija knjiga, Planjax komerc, Association of Publishers of Textbooks and Teaching Resources, Association of Publishers of the Republic of Srpska, Synopsis, Croatian Lexicographic Institute Mostar, Imprimatur, Association of literary creators, publishers and booksellers in BiH, Publishing company and services Dobra knjiga d.o.o. etc. making a total of 46 holders (authors and publishers) to private and other internal use. The authors registered a total of 426 works consisting the repertoire of association and 1996 works were registered by publishers, this total amounts to 2442 works that are registered as a repertoire of the collective organization.

Having in mind the total number of right holders in BiH, who are members of the ORIGINAL association and the repertoire of the association, as well as the fact that the organization has requested the issuance of a license for the realization of those rights of authors and publishers for which collective law is mandatory, and that the members of the association are also professional associations of holders of rights to private and other internal use, and that the holders of these rights cannot exercise their rights without collective organization, Institute estimates that the association ORIGINAL gathers the majority of the holders of rights in the area related to the activity of the collective organization.

5) The Association for the Realization and Protection of Reproduction Rights "ORIGINAL" meets the technical requirements in terms of Article 5 of the Ordinance relating to business premises and equipment, means of communication, own Internet address and e-mail address

6) The Association for the Realization and Protection of Reproduction Rights ORIGINAL meets the requirements of the professional service and staff assumptions regarding the persons currently working and the development projections of the professional service and that the person employed in the professional service comply with Article 10 paragraph (2) item d) of the Law and Article 6 of the Bylaw.

7) The Association for the Realization and Protection of Reproduction Rights "ORIGINAL" has submitted a proper business plan and decision of the Assembly of the Association on the adoption of a business plan in accordance with Article 7 of the Bylaw, which determines that the economic basis of the Association for the Realization and Protection of Reproduction rights ORIGINAL is sufficient to enable undisturbed operation and effective exercise of rights especially having in mind the number of right holders residing in Bosnia and Herzegovina who have joined the ORIGINAL Association for Realization and Protection of Reproduction Rights, the total number of their works that will constitute the repertoire of the association, the presumed scope of the use of the work, i.e. possible number of their users, the manner and means in which the collective organization intends to carry out its activity, and an estimation of the expected amount of collected fees and operating expenses.

The business plan states that it is planned to realize the total income in the amount of BAM 60,000 in the first year of operation. In the coming years, the total revenue is planned to increase, so that it is planned to generate a total income of BAM 420,000 in 2019. It is planned that the allocation of funds will be made in accordance with Article 22 paragraph (2) of the Law on the Collective Management of Copyright and Related Rights and the rules and principles of distribution established by the Statute of the ORIGINAL Association, i.e. that the fee will be divided between the author and the publisher in the ratio of 50: 50, after deducting operating costs.

The funds planned for carrying out the activities of the collective organization (operating costs) will be taken from the collected fees from the beneficiaries, which will be slightly more than 30% in the first two years of the business, while it is anticipated that the costs for the third year will be below 20%, which is in accordance with international standards.

8) That foreign collective organizations have expressed readiness to conclude reciprocal contracts in the event that the association ORIGINAL obtains a license for the collective management of rights to private and other internal use authors of written works issued in paper form and related rights of the publisher of printed editions. Statements obtained from: IFRRO Belgium, Public Union from Azerbaijan, Dilia from Prague, Kopipol from Poland, Lita from Slovakia, RSZ from Hungary, Repro Bel from Belgium, Sazor giz from Slovenia, Zana from Croatia and YAYBIR from Turkey.

Based on a conscientious and careful evaluation of all the evidence in particular, as well as all the evidence together and the results of the entire proceedings, the Institute issued a decision as in the enacting clause. According to Article 11 paragraph (6) of the Law on the Collective Realization of Copyright and Related

Rights, the notice on the decision on issuing a license shall be published in the Official Gazette of BiH and in the Official Gazette of the Institute and it has been decided as in the enacting clause of this decision.

Legal remedy: This decision is final in the administrative procedure. An administrative dispute may be initiated against this decision by filing a lawsuit with the Court of Bosnia and Herzegovina within 60 days from the date of receipt of the decision.
